CURRENTLY CALIFORNIA HAS WEAK STATE LEVEL LIGHT POLLUTION CODES. THE STATE LEVEL PLANNING TEAM IS INTERESTED IN TESTING OUT SOME IDEAS FOR HOW TO IMPROVE THEM, AND USING SANTA CRUZ AS A CASE STUDY. THIS **INTERNSHIP WOULD INVOLVE** TITLE: WRITER/CONSULTANT INTERVIEWING AND COORDINATING WITH LOCAL CITY STAFF AND ELECTED OFFICIALS TO EXPLORE OPTIONS, UNDERSTANDING AVAILABLE GIS MAPPING INFORMATION. AND REPORTING UP TO THE STATE LEVEL PLANNING GROUP ON THE FEASIBILITY OF THE APPROACH.
